Racking system is used in Industry more particularly in warehousing and storage. It is one of the neglected areas of Health and Safety in the company. Racking inspection is not yet recognised as statutory requirement in any Factory Rules, but Rack Safety Inspection is optional activity as advised by many Auditors during their Audits.

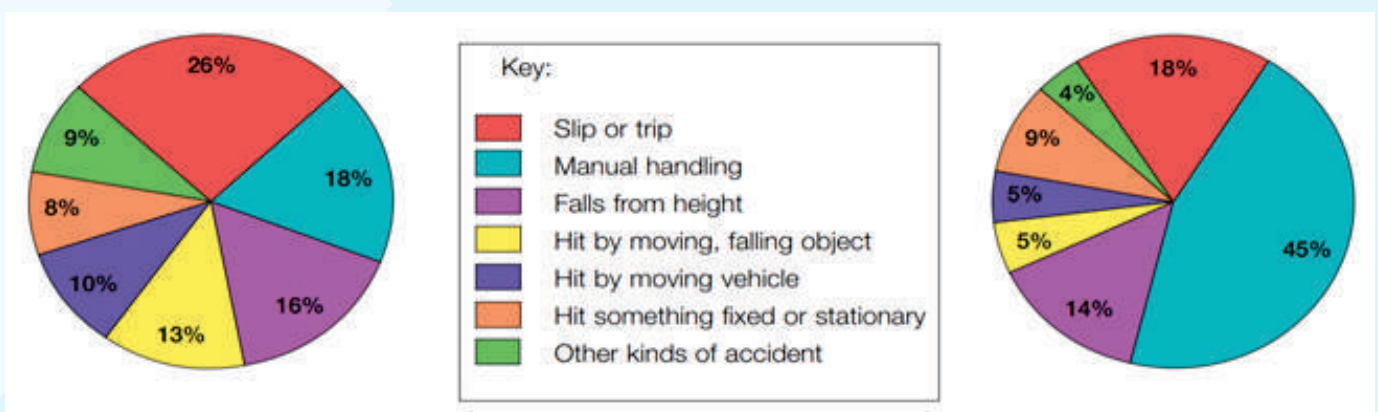
Most of the time the SWL capacity (Safe Working Loading Capacity and Identification Nos.) are not specified in the storage rack system. Racking system is also found not anchored or secured properly at the bottom as well as on the top of the rack system. Many small incidents (Slipping or Tripping)



are taking places in warehouse during manual and / or mechanical handling of various loads at different heights apart from storages of dangerous substances.

Periodical Inspection / Examination / Certification of Racking system used / installed in warehouses and storages of Industry from a authorized Competent Person will help the organization to prevent Sliper Trip Hazards, Fork Lif or Stacker, Transport Hazards, Electrical Safety, Accidents and Emergencies.

On Site Emergency Plan Preparation

It is a legal document that provides the details of emergency planning and emergency preparedness of the organization for handling different kinds of emergencies (natural or accidental) on its occurrence. On site plan preparation is required as a part of statutory compliance, especially for MAH Units as well as process units where hazardous operations are involved. These are prepared as per certain guidelines and they are required to be updated at least once in 2 years. We have prepared more than 100 on site emergency plans for various industries and witnessed mock drill programs for more than 200 Industries.

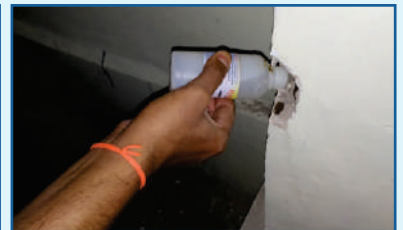

Evaluation of Failure Analysis and Investigation Report on Industrial Accidents



“All Accidents are preventable.”

This is generally said when the causes for an accident are identified and removed completely.

Generally all pressure parts and the temperature affected parts (due to creep) Such as pressure vessels, pressure piping are found under various stresses and strains. If operations are not carried out methodically, if there is zero or minimum maintenance or changes in circumstances/situations, then the probability of failures increases and sudden breakdown occurs which result in heavy losses to process industries.





Remaining Life Assessment (RLA) Studies and NDT Testing for IBR Boilers

When a Boiler nears 25 years or 100000 hours (whichever is earlier) in operation, it is suggested by the IBR Authority to carry out systematic NDT Testing and / or Semi RLA or RLA on various pressure parts of these boilers for assessment of its remaining life and the necessary repairs or reconditioning required.

Ndtee Services Pvt. Ltd. Is an agency approved by the Office of the Director of Steam Boilers Mumbai for carrying out the Remaining Life Assessment (RLA) of IBR Boilers and has also applied for 'well known RLA Organisation' with the Central Boiler Board.
